### **VOTING TERMS AND CONDITIONS**

### A. The Voting Mechanics and Eligibility

- The MUZIKAL LAWAK SUPERSTAR 5 ONLINE VOTING SYSTEM ("Voting") is organised by Measat Broadcast Network Systems Sdn. Bhd. (Company No. 199201008561 (240064-A)) ("Astro") for viewers of the MUZIKAL LAWAK SUPERSTAR 5 GAMESHOW ("Gameshow") to vote for their favorite contestants.
- 2. The Gameshow is a reality show which will be broadcasted on the Astro PRIMA Channel. The Gameshow will feature selected participants competing in groups of three (3) members ("Contestants") to become the winner of the Gameshow. Each week, the Contestants will perform musical comedic sketches, skits, and/or routines according to the assigned weekly location themes and music genre. At the end of each episode, Contestants awarded the lowest score based on the Scoring Mechanism will be eliminated from the Gameshow in a manner determined solely by Astro until one Contestant is declared the winner of the Gameshow.
- 3. The scoring mechanism of the Gameshow shall be as follows ("Scoring Mechanism"):
  - (a) 80% of the total score shall be awarded by a panel of three (3) judges ("**Appointed Judges**") who will base their evaluations of each Contestant's performance during each weekly episode as follows:

Storyline	20%
Storyline Structure	20%
Comedy	20%
Creativity	20%
TOTAL	80%

- (b) the remaining 20% of the total score shall be from the online votes cast by audience and the general public ("Voters"). Voters will be able to cast their online votes trough the following website: <a href="www.gempak.com/muzikallawaksuperstar">www.gempak.com/muzikallawaksuperstar</a> ("Astro Gempak Website") using Single Sign On ("SSO") login. Each user of the SSO is eligible to submit:
  - (i) up to fifty (50) votes on a day where the live weekly episode is broadcast (Saturday); and
  - (ii) up to thirty (30) votes on any other day (Sunday to Friday).

In the event of a tie, the score awarded by the Appointed Judges will serve as the tie-breaker. If there is still a tie, the final decision shall be made by Astro.

For the avoidance of doubt, Astro reserves the absolute right to change the designated live episode broadcast day, and the days stated under Clause 3(b) shall be deemed amended accordingly.

- (c) Any leaderboard or scoreboard exhibited during each episode of the Gameshow and/or on the Astro Gempak Website during the Gameshow period and/or Voting Period (as hereinafter defined) are not final and shall be subject to verification by Astro.
- 4. The Voting shall be held from 2000hrs on 11<sup>th</sup> October 2025 to 2359hrs on 29<sup>th</sup> November 2025 or such other time as may be determined by Astro ("**Voting Period**") at its sole discretion. During the Voting Period, the Voting will be divided into weekly blocks where the closing of each block shall be announced by the host of the Gameshow or any other authorised representative of Astro during each weekly episode of the Gameshow ("**Weekly**")

At the end of each episode, the host of the Gameshow or any other authorised representative of Astro will announce the Contestant who will be eliminated and removed from the voting system. Votes collected by the remaining Contestants from each Weekly Voting Block are not cumulative and will be disregarded for the computation of votes for the next Weekly Voting Block, with the votes for each Contestant being reset to zero (0) at the beginning of each Weekly Voting Block.

- 5. For clarity, the votes will be reset to zero (0) even where no elimination been announced.
- 6. The Contestant's nicknames are as listed below:

### B. Charges

No charges will be imposed by Astro for participating in the Voting.

### C. Voting Entries

- 1. Each vote submitted shall be deemed as one (1) voting entry by the Voter ("Voting Entry").
- 2. The votes submitted shall be subject to the maximum daily votes as specified in Section A(3)(b) above.
- Each Voter shall be solely responsible to ensure that their Voting Entries are complete and accurate. Astro shall have the right to disqualify Voting Entries which are deemed by Astro at its sole and absolute discretion to be incomplete, invalid or not made in accordance with the Terms and Conditions herein.
- 4. Voters under the age of eighteen (18) must seek parental and/or guardian approval before participating in the Voting. Astro considers it the responsibility of parents and/or guardian to monitor their children's (who are below the requisite age) participation in this Voting.

## D. Proof of Receipt

Proof of a Voting Entry sent by a Voter does not constitute proof that the Voting Entry was received by Astro.

### E. Adherence to Voting Terms and Conditions

All Voters shall be required to adhere to these Voting Terms and Conditions including any changes made thereto from time to time at Astro's sole and absolute discretion.

### F. Variation to the Terms and Conditions

Astro reserves the right to change, amend, modify, vary, alter, delete or add to these Voting Terms and Conditions without prior notice at any time and the Voters shall be bound to such changes.

Astro shall not be responsible or liable in any way whatsoever for:

- any problem, loss or damage of whatsoever nature suffered by any party due to any delay and/or failure in receiving and sending an online vote as a result of any network, telecommunication or system error, interruption and/or failure experienced by the Voter's telecommunication service provider and/or by Astro and/or resulting from participation in the Voting howsoever arising. In the event of such error, interruption and/or failure, Astro shall not be responsible or liable for any failure by any Voter to participate in the Voting at any time;
- 2. any problem, damage or loss of whatsoever nature suffered by the Voters, or their authorized representatives resulting from their participation in the Voting;
- 3. any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, destruction, alteration of or unauthorised Voting Entries howsoever arising (including without limitation as a result of server malfunctions, virus, bugs, human or technical error or other causes outside its control); and
- 4. any other errors, acts or omissions whatsoever by the participating telecommunication service providers of the Voting.

### H. <u>Disqualification</u>

Without prejudice to any rights which Astro may have in law, Astro reserves the right at its sole discretion to disqualify any Vote that it determines to be tampering with the entry process or the operation of the Voting, or to be acting in breach or potential breach of these Voting Terms and Conditions.

### I. Suspension

Astro further reserves the right to cancel, terminate, modify, suspend or delay the Voting in the event of unforeseen circumstances beyond its reasonable control or for any reasons whatsoever at the sole and absolute discretion of Astro.

### J. Governing Law

These Voting Terms and Conditions shall be construed, governed and interpreted in accordance with the laws of Malaysia.
