

GEMPAK MOST WANTED AWARDS 2025

TERMS AND CONDITIONS

A. Basic Terms

1. Name of Awards Show:

1.1 Gempak Most Wanted Awards 2025 or GMWA 2025 ("Awards Show") is an award show for the entertainment industry organised by **MEASAT BROADCAST NETWORK SYSTEMS SDN. BHD. (Company No. 199201008561 (240064-A))** ("Organiser"), and which will be held on 15th February 2026 at Dewan Auditorium Majlis Bandaraya Shah Alam (MBSA). The Award Show will be simulcast on ASTRO RIA HD channel (CH104), Astro Gempak social media channels on platforms such as Facebook, YouTube, TikTok, X (formerly known as Twitter) and Astro Gempak website at www.gempakmostwantedawards.com.

2. Brief Description and Mechanism of Awards Show:

2.1 The Award Show is a people's choice award held to recognise top digital personalities and talents in the local lifestyle and entertainment industry ("Nominees"). The award categories in the Award Show relate to five (5) digital platforms namely Facebook, Instagram, Tik Tok, YouTube and X (formerly known as Twitter) ("Digital Platforms").

2.2 Members of the public may log on to the official website of Gempak Most Wanted Weekly Show (www.gempak.com/gempakmostwanted) to cast votes for their favorite Nominees. Nominees will be shortlisted based on the total number of votes submitted by the public. Nominees will then earn points based on their ranking in the Top 5 Weekly Charts.

2.3 A total of fourteen (14) categories of awards ("Awards") shall be awarded during the Award Show, as follows:

Digital Creator (Foodie) Tergempak 2025	Personalities and talents who create content related to food and beverage such as cooking, food/cooking-related reviews, ASMR, and Live content, and have a minimum of 100,000 subscribers/followers across all Digital Platforms within the Eligibility Period.

Digital Creator (Beauty & Fashion) Tergempak 2025	Personalities and talents who create beauty and fashion related content relating to makeup, beauty product reviews, Inspo (Inspiration), and Live content, and have a minimum of 100,000 subscribers/followers across all Digital Platforms within the Eligibility Period.
9.		Digital Creator (Sports) Tergempak 2025	Personalities or talents who create content related to sports, fitness, or electronic video games, including streamers and casters, and have at least 50,000 followers across all Digital Platforms within the Eligibility Period.
10.		Drama Tergempak 2025	Any clips, segments, promo trending TV and/or digital drama series across all Digital Platforms which garnered at least 1 million total views within the Eligibility Period.
11.		Video Muzik Tergempak 2025	Official music videos that have garnered 1 million or more views across all Digital Platforms within the Eligibility Period.
12.		Lagu Era Tergempak 2025	A trending song/audio in Carta Era 40, that has garnered 500,000 or more views across all Digital Platforms or has at least 1,000 uses on TikTok within the Eligibility Period.
13.		Selebriti Tergempak 2025	Entertainment celebrities (singers, actors, comedians, musicians, entertainers, etc.) who are trending and have a minimum of 50,000 followers across all Digital Platforms within the Eligibility Period.
14	Special Award by the Selection Committee Members	Gempak Hall of Fame 2025	Personalities and talents who have given impactful actions to the society with such actions leaving talkability on digital platforms.

2.4 For the purpose of the Qualifying Criteria stated above, Eligibility Period shall mean the period between 15th November 2024 and 15th October 2025 (both dates inclusive).

2.5 Nominees must adhere to the mechanism of the Awards Show as may be briefed and communicated to the Nominees by the Organiser during the Award Show Period.

2.6 Award No. 1 will be decided by the highest combined score derived from both public voting and jury voting shall be declared the winner.

2.7 For Awards 2 to 13, the Nominee with the highest combined score derived from both the public

voting and jury voting shall be declared the winner of the respective category. Votes shall be cast via voting mechanism provided below.

- 2.8 Award 14 shall be decided solely by the Selection Committee Members.
- 2.9 In the event of a tie, the Selection Committee Members shall cast a deciding vote to determine the winner of the respective category and/or the recipient of the main award. The decision of the Selection Committee Members shall be final and binding.
- 2.10 Selection Committee Members shall consist of representatives from Gempak, Astro Ria, ERA, and Astro Studios, who shall be chosen at the sole discretion of the Organiser.
- 2.11 Each Winner shall be chosen via the mechanism provided herein.
- 2.12 Each Award shall only have one (1) Winner.
- 2.13 In the event that a Nominee is, or becomes, the subject of allegations or circumstances which may be considered ethically or morally inappropriate, publicly contentious, or reputationally damaging whether to Nominee itself or potentially damaging to the Award, the Awards Show and/or the Organiser, and whether within the context of the award category or in a broader personal or professional capacity, the Selection Committee Members reserves the absolute right to determine the outcome, including but not limited to the disqualification of the Nominee, or the withdrawal or reassignment of the Award, at its sole and absolute discretion.
- 2.14 Ethically or morally inappropriate, reputationally damaging, or publicly contentious matter shall include, without limitation, any circumstance, conduct, or public disclosure involving a Nominee which may reasonably be perceived to harm the integrity, credibility, or public image of such Nominee, the Award, and/or the Organiser. This includes, but is not limited to, allegations of misconduct, legal disputes, violations of professional or ethical standards, or any issue that has attracted negative public attention or controversy.
- 2.15 Ranking (as appearing on the leaderboard) and all votes are subject to verification. Winners will be officially announced in accordance with the Award Announcement below.
- 2.16 The Organiser shall not be obliged to select Winner(s) nor provide any compensation whatsoever to the Nominees in the event that the Awards Shows cancelled or postponed for any reason whatsoever. By agreeing to participate in the Awards Show, the Nominees acknowledge and agree that the Organiser shall not bear any liabilities whatsoever in this regard.
- 2.17 The Organiser's decision will be final and no queries and/or appeals will be entertained.

3. Eligibility Criteria:

- 3.1 Subject to other criteria set out herein and in the Standard T&C, the Awards Show is open to Malaysians and non-Malaysians provided that they satisfy the Age of Eligibility below:
 - (a) **For Malaysian Nominees:**

Digital personalities and talents must possess a valid Malaysian National Registration Identity Card (NRIC).
 - (b) **For Non-Malaysian Nominees:**
 - (i) Digital personalities and talents must reside in Malaysia and possess a valid International Passport, OR
 - (ii) Digital personalities and talents residing outside Malaysia but have content that is in collaboration with a Malaysian. Nominees must possess a valid International Passport,

- (c) Nominees have not been convicted of any criminal offence as at the date hereof or under any investigations or charge for any criminal offence (but exclude road traffic offences); and
- (d) Nominees have not been declared a bankrupt in the preceding six (6) years nor under any bankruptcy proceedings as at the date hereof.

3.2 The Top 10 Nominees are required to attend the Awards Show live event. If any of the said Top 10 Nominees is unable to attend, they are required to send an acceptance video or send a representative to attend the Awards Show live event.

3.3 The Organiser shall be entitled to request to sight the original Identity Card or the originals of other supporting documents/materials for verification purposes.

4. Ineligibility

- (a) Employees of the Organiser, the Producer and its respective subsidiaries and associated companies, and their *immediate family members;
- (b) Employees of all the Sponsors and their *immediate family members; and
- (c) Selection Committee Members and their *immediate family members.

**immediate family members" means spouse, children, parents, brothers and sisters; inclusive of adoptive members.*

5. Age of Eligibility:

There is no age restriction for participation in this Award Show. However, Nominees who are below the age of 18 or such other age of majority pursuant to the relevant jurisdiction applicable to the Nominee must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in the Awards Show and/or to receive the Award. The Organiser considers it the responsibility of parents and/or guardian to monitor the participation of their children (who are below the requisite age of majority) in this Awards Show.

6. Charges:

The Organiser does not charge for entries submitted by the Nominees and/or the general public. All costs incurred for the Awards Show including without limitation to, preparation and submission of entries shall be at the Nominees' or the public's own expense, as applicable.

7. Awards Show Period:

7.1 The Awards Show Period is as follows:

Filtration Period - Top 10 Nominees (Awards 2 to 13):	15 th October 2025 – 19th December 2025
Top 10 Nominees Announcement (Awards 2 to 13):	14 th January 2026
Public Voting Period - Top 10 (Awards 2 to 13):	15 th January 2026 – 15 th February 2026 (12:00pm)
Jury Voting Period – Top 10 (Awards 2 to 13):	15 th January 2026 – 15 th February 2026 (12:00pm)
Awards Show Live Event (Awards 1 to 14):	15 th February 2026

7.2 The Organiser reserves the right to amend, postpone or re-schedule the Awards Show Period or any date thereof at its sole discretion.

8. **Entry Deadline:**

8.1 The entry deadlines shall be as follows:

Nomination Period (Awards 2 to 13):	15 th October 2025
Public Voting Period– Top 10 (Awards 2 to 13):	15 th February 2026, 12:00PM
Jury Voting Period– Top 10 (Awards 2 to 13):	15 th February 2026, 12:00PM

8.2 Entries must be received within the time frame stipulated above. Entries received before the commencement of the relevant Awards Show Period and after the stipulated Entry Deadline will be disqualified and ineligible for consideration for participation and/or prizes.

9. **Language of Awards Show:**

The Awards Show will be organised and produced by the Organiser in Bahasa Melayu and English.

10. **Entry Procedure:**

10.1 Nomination Mechanisms (Awards 2 to 13)

(a) During the Nomination Period, an online form will be made available on the official website of the Awards Show (www.gempak.com/gempakmostwanted) ("Official Website"). The general public are required to submit their nominations through the form provided within the Nomination Period. Members of the public may submit multiple nominations for any one Award category. The Qualifying Criteria of each relevant Award are as stipulated in the table above. If there are no nominations received for any of the Award categories, the Organiser reserves the right to cancel such Award category or obtain suitable nominations through other means as necessary for the relevant Award category as it shall, in its sole discretion deem fit, without liability to any Nominees at any time for any reason whatsoever.

(b) All nominations shall then be filtered via the Filtration Mechanisms below.

10.2 Filtration Mechanisms (Awards 2 to 13)

(a) **Point Earning System and Weekly Chart**

(i) Members of the public will vote for their favorite Nominees on a weekly basis through the Official Website. Every week, the Top 10 Nominees for all the categories will have their points recorded as below:

(ii) Weekly results will be announced during the Gempak Most Wanted Weekly Show, which airs every Wednesday at 11PM on Astro Ria HD channel (CH104). The highest accumulated points in the system within the Nomination Period and according to the Qualifying Criteria above will stand a chance to be qualified as the Top 10 Nominees for Awards 2 to 13.

(b) **Top 10 Nominees Filtration:**

- (i) Top 10 Nominees for Awards 2 to 13 will be selected based on the highest accumulated points in the system and Qualifying Criteria as described above.
- (ii) The Top 10 Nominees for Awards 2 to 13 will be open for public voting through the voting mechanism below.

(c) **Top 5 Nominees:**

Top 5 Nominees for Awards 2 to 13 will be determined through votes submitted by members of the public and the jury, in accordance with the voting mechanism below.

10.3 The Organiser and the Selection Committee Members reserve the absolute right to disqualify any entries should there be reasonable grounds to suspect that any fraudulent submissions have occurred or any attempt to rig the voting. The Organiser and the Selection Committee Members also have the right to substitute any affected Nominee with a replacement at its absolute discretion. The Organiser and the Selection Committee Members reserve the right to assess and determine the suitability of the Nominees in a submitted category.

11. Public Voting Mechanism (Awards 2 to 13)

11.1 Votes submitted by the general public (“**Public Vote(s)**”) shall constitute fifty percent (50%) of the total voting outcome.

11.2 Voters are required to log in to the Official Website (www.gempak.com/gempakmostwanted) and register for an account via an active Google, Facebook or Astro account (“**Public Voter**”) in order to vote for their favorite nominee from the Top 10 Nominees and eventually the Winners of Awards 2 to 13.

11.3 Each Public Voter registered under a valid email address for the relevant Google/Facebook/Astro account is allowed to cast their Public Votes per award category (for Award 2 to 13) daily during the respective voting periods as follows:

11.4 The Organiser reserves the right to disqualify or suspend any voting if it has reasonable grounds to suspect that any fraudulent voting has occurred or if it has reason to suspect that there has been any attempt to rig the voting system. The Organiser reserves the absolute right to substitute the voting mechanism for another voting method at its absolute discretion.

- 11.5 If, for any reason, the voting system fails, the voting may be suspended, or a contingency plan may be carried out at the Organiser's absolute discretion.
- 11.6 The Organiser reserves the right to change, cancel or suspend the Public Voting at any time.
- 11.7 Proof of voting sent by a Public Voter does not constitute proof that the Public Votes were received by the Organiser.
- 11.8 Public Voters must ensure that their Public Voting entries are complete and accurate. The Organiser shall have the right to disqualify any Public Voting entries which are incomplete, invalid or not made in accordance with the Terms and Conditions herein.
- 11.9 The Organiser shall not be responsible or liable for:
 - (a) any problem, loss or damage of whatsoever nature suffered by any party due to any delay and/or failure in receiving and sending a Public Vote as a result of any network, telecommunication or system error, interruption and/or failure experienced by the Public Voter's telecommunication service provider and/or by Organiser and/or resulting from participation in the Public Voting howsoever arising. In the event of such error, interruption and/or failure, Organiser shall not be responsible or liable for any failure by any Public Voter in participating in the Public Voting at any time;
 - (b) any problem, damage or loss of whatsoever nature suffered by any Public Voter, or their authorised representatives resulting from their participation in the Public Voting;
 - (c) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, destruction, alteration of or unauthorised voting entries howsoever arising (including without limitation as a result of server malfunctions, virus, bugs, human or technical error or other causes outside its control); and
 - (d) any other errors, acts or omissions whatsoever by the participating telecommunication service providers of the Public Voting.

- 11.10 Where applicable, Public Voters must obtain consent from the Bill Payers before participating in the Public Voting. Payment shall be made irrespective of whether such Public Votes were authorised by the Bill Payer. For the purposes herein, the term "**Bill Payer**" shall mean *the individual, company or entity specified in the registration or subscription form whose application for the relevant telecommunication service has been approved and accepted by the telecommunication service provider it subscribes to*. The Organiser shall not entertain any complaints (whether made orally or in writing) concerning such unauthorised Public Votes made by any Public Voters.

12. Jury Voting Mechanism (Awards 2 to 13)

- 12.1 Votes cast by the appointed jury ("**Jury Votes**") shall constitute fifty percent (50%) of the total voting outcome.
- 12.2 The appointed jury ("**Juror(s)**") shall consist of recognised leaders of the entertainment industry or industry professionals with relevant expertise.
- 12.3 Any Juror who is determined to have a conflict of interest in relation to a specific Award category shall be recused from participating in the voting process for such category.

12.4 **Jury Voting Method**

(a) **Point-Earning System**

The Organiser shall distribute a secured online form to each Juror via email, within the designated voting period, to facilitate the submission of Jury Votes for each Award category.

Each Juror shall independently assign rankings to the Nominees within such Award category, with Rank 1 (highest) receiving 10 points and Rank 10 (lowest) receiving 1 point, as demonstrated in the table below:

(b) **Total Earning Points**

The points awarded by all Jurors are then aggregated for each Nominee. The total accumulated points for each Nominee represents their score for the Juror evaluation, which constitutes 50% of the final assessment. The Nominee with the highest combined score from both Jury Votes and Public Votes will be declared the winner of the respective Award category.

13. **Award Announcement:**

Winners for respective Award categories will be announced during the Award Show live event on 15th February 2026 at 9pm.

14. **General:**

The Basic Terms and the Standard Terms and Conditions (collectively “**Terms and Conditions**”) and the Privacy Notice shall be binding on all participants who participate in this Awards Show (“**Nominees**”). The definitions in the Standard Terms and Conditions shall apply unless otherwise expressly stated in the Basic Terms. In the event of any inconsistency between the Basic Terms, the Standard Terms and Conditions and the Privacy Notice, the Basic Terms and the Privacy Notice shall prevail to the extent of such inconsistency.

15. **Acceptance:**

Entry and participation in the Awards Show shall be deemed an unconditional acceptance by the Nominees of the Terms and Conditions and the Privacy Notice.

B. STANDARD TERMS AND CONDITIONS

1. INTRODUCTION

- 1.1 This Standard Terms and Conditions ("Standard T&C") shall govern the Awards Show that is organised by the Organiser as named in the Basic Terms. The Standard T&C shall be in addition to the terms as set out in the Basic Terms (the Basic Terms and the Standard T&C shall collectively be referred to as "Terms and Conditions").
- 1.2 The Awards Show will be held during the Awards Show Period as set out in the Basic Terms. The Organiser reserves the right to vary, postpone or re-schedule the dates of the Awards Show or extend the Awards Show Period at its sole discretion.
- 1.3 The brief mechanism of the Awards Show is set out in the Basic Terms. The Nominees must adhere to the mechanism of the Awards Show as may be briefed and communicated to the Nominees by the Organiser from time to time during the Awards Show Period.
- 1.4 The Awards Show will be organised by the Organiser in the Language as set out in the Basic Terms.
- 1.5 The Entry Procedure of the Awards Show is as set out in the Basic Terms.
- 1.6 The Organiser reserves the right to at any time, change, amend, delete or add to the Terms and Conditions and other rules and regulations including the mechanism of the Awards Show at its absolute discretion.
- 1.7 The Organiser may terminate or suspend the Awards Show at any time at its absolute discretion in which case, the Organiser may elect not to award any prize or awards. Such termination or suspension will not give rise to any claim by the Nominees. If the Awards Show is resumed by the Organiser, the Nominees shall abide by the Organiser's decision regarding resumption of the Awards Show and disposition of the Prizes.

2. APPLICATION FORM

- 2.1 If so required, the Application Form must be complete, filled up accurately and signed by the Nominee and sent to the Organiser vide the Mode and to the Address together with such other documents as may be required as set out in the Basic Terms. Entries must be received by the Organiser on or before the Entry Deadline as set out in the Basic Terms.
- 2.2 By submitting the Application Form, the Nominees shall be deemed to have read, understood, accepted and agreed to be bound by the Terms and Conditions of the Awards Show.
- 2.3 All statements made and information provided by the Nominees to the Organiser in the Application Form must be true correct, accurate and complete.
- 2.4 Submission of the Application Form does not guarantee the Nominee the opportunity to participate in the Awards Show. The Organiser shall be entitled to reject or refuse participation by the Nominee for reasons, including (without limitation) where the Application Form is not complete or any provisions in the Terms and Conditions is not fulfilled or adhered to by the Nominee.
- 2.5 Without prejudice to Clause 2.4 above, the process of selection of Nominees is at the Organiser's sole discretion and even if the Nominee has been selected as a participant of the Awards Show, the Organiser is nevertheless not obliged to have the Nominee as a participant in the Awards Show.

3. ELIGIBILITY

- 3.1 The Eligibility Criteria are as set out in the Basic Terms.
- 3.2 Nominees may be required to submit further proof of their eligibility within such timeframe as may be required by the Organiser failing which the Organiser shall be entitled to disqualify the Nominee.

4. INELIGIBILITY

- 4.1 Persons ineligible to participate in the Awards Show as are set out in the Basic Terms.

5. DISQUALIFICATION

- 5.1 The Organiser reserves the right to disqualify Nominees and/or revoke the Prize (at any stage of the Awards Show) if:-
 - 5.1.1. The Nominee is ineligible or does not meet any of the Eligibility Criteria;
 - 5.1.2. The Nominee breaches of the Terms and Conditions or other rules and regulations of the Awards Show;
 - 5.1.3. The Nominee is found to have consumed any illegal drug or indulged in substance abuse during the recording of the Programme;
 - 5.1.4. in the Organiser's sole determination, it believes that the Nominee has attempted to undermine the operation of the Awards Show by fraud, cheating, deception or conduct deemed unacceptable to the Organiser; or
 - 5.1.5. at the Organiser's sole determination, the participation by Nominee is not suitable or may pose any health risk to the Nominee or for any reasons whatsoever.

- 5.2 In the event of a disqualification after an Award has been awarded, the Organiser reserves the right to demand for the return of the Award or payment of its value from the ineligible or disqualified Nominee.

- 5.3 Whilst the Organiser will endeavour to conduct necessary verifications on the eligibility of Nominees, failure to disqualify any ineligible Nominee shall not be deemed a breach by the Organiser.

6. WARRANTIES

- 6.1 The Nominee represents, warrants and agrees with the Organiser that:-

- 6.1.1 the Nominee has met all the eligibility criteria and has the right, authority and power to enter into this Awards Show and shall provide such proof as the Organiser requires;
- 6.1.2 all statements made and information provided by the Nominee to the Organiser are true correct, accurate and complete;
- 6.1.3 the Nominee has the right, authority and power to grant the rights set out in Clause 7 of the Terms and Conditions of this Awards Show and is under no restriction (contractual or otherwise) that may prevent the Organiser from using and/or exploiting the same;
- 6.1.4 the Nominee's participation in the Awards Show and/or Programme does not entitle the Nominee to any wages, salary or any other compensation;
- 6.1.5 the Nominee shall not, during the Awards Show or thereafter engage in any act or words that shall be defamatory, obscene or profane of the Awards Show, the Organiser and/or

the Organiser's affiliates;

- 6.1.6 the Nominee has not been and shall not be involved or participate in any dishonest, deceptive or fraudulent act or conduct in relation to the Awards Show or Programme. The Nominee agrees that the Nominee is aware that it is a breach of the Terms and Conditions and the rules of the Awards Show for the Nominee or anyone else to offer or accept any special or secret assistance to rig the outcome of the Awards Show. The Nominee agrees that the Nominee will not participate in any such act or any other deceptive or dishonest act with respect to the Awards Show and that if anyone tries to induce the Nominee to do so such act, the Nominee shall immediately notify the Organiser;
- 6.1.7 The Nominee has not accepted and shall not accept endorsements from any third parties any monies, service or other valuable consideration for the inclusion of any "plug", reference, product identification and/or any other matter in the Awards Show and/or Programme;
- 6.1.8 The Nominee agrees that the Nominee shall not make any arrangement with any third party whereby any person may acquire the right to advertise, promote, sell, package or display goods or services or merchandise of any description using the Nominee's name or any reproduction of the physical likeness of the Nominee in association with the appearance of the Nominee in the Awards Show without the prior written consent from the Organiser;
- 6.1.9 The Nominee is in a good state of health and free of any serious and/or contagious illness;
- 6.1.10 The Nominee warrants that all the statements made by the Nominee to the Organiser are true correct accurate and complete and agrees that all Awards (if awarded) is contingent upon the accuracy of the information provided and disclosures made by the Nominee and the full and complete performance of the Nominees warranties, undertakings and obligations hereunder; and
- 6.1.11 the Nominee agrees that the Nominee shall not without the prior written consent from the Organiser publish or disclose any information in connection with the Awards Show or Award (including without limitation, to any representatives of media in any form whatsoever).

- 7.1.6 agrees that the personal data of the Nominee including, but not limited to, name, mailing address, phone name and email address may be collected, processed, stored and otherwise used for the purposes of conducting and administering the Awards Show and used in the ordinary course of the Organiser's business as it sees fit.

8. AGREEMENT

9. Awards

9.1 The Awards for the Game Show shall be as set out in the Basic Terms.

9.3 In the event that the Nominee chooses not to accept an Award, the Award shall be forfeited and be dealt with according to the absolute discretion of the Organiser.

9.4 Where awarded non-cash prizes, the Nominee shall not be entitled to redeem the same for cash or other alternatives.

- 16.4 The invalidity, illegality or unenforceability of any terms hereunder shall not affect or impair the continuation in force of the remainder of the Terms and Conditions of the Awards Show.

In the event of any inconsistency between this English language and any other languages, the English language version shall prevail and govern in all respects.
