TERMS AND CONDITIONS

1. Brief Description and Mechanism of Award

- i. Astro Classic Golden Melody Singing Competition 2025 ("**CGM 2025**") is a singing competition show ("**Competition**") organised by Measat Broadcast Network Systems Sdn Bhd and/or its affiliates (hereinafter referred to as "**Organiser**"). The Grand Finale of the Competition will be broadcast on 4th October 2025 on Astro AEC HD (Channel No. 306).
- ii. The CGM 2025 Mah Sing People's Choice Award ("**Award**") is held by the Organiser for members of the public to submit online votes ("**Voters**") for their favourite Top 8 Finalists in the Competition ("**Voting**"). The relevant Top 8 Finalist with the highest number of votes will be the winner of the Award, which will be announced during the telecast of the Grand Finale.
- iii. The Voting shall be held from **10:00 pm on 27th September 2025 until 10:00 pm on 4th October 2025** or such other time as may be determined by the Organiser at its sole and absolute discretion ("**Voting Period**").
- iv. All Voting Entries must be received by the Organiser on or before **10:00 pm on 4th October 2025** ("**Voting Deadline**"). Voting Entries received before the commencement of the Voting Period or after the stipulated Voting Deadline will be disqualified.
- v. In the event of a tie in the Voting, the representative(s) of the Main Sponsor and/or the representative(s) of the Organiser shall have the sole discretion to determine the Winner of the Award.
- vi. The Winner of the Award will receive a cash prize of **RM8,888.00** sponsored by the main sponsor of the Competition, Mah Sing Group Bhd ("**Main Sponsor**").

2. Voting Mechanics and Eligibility

There will be only one (1) method for Voters to submit their Voting Entries as follows:

- i. The Voters are required to log in to the website, <http://voting.astro.com.my/cgm2025> ("**Voting Webpage**") with a valid Astro ID.
- ii. After logging in to the Voting Webpage, the Voters can then begin to vote for their favourite Contestant(s) with their Allocated Votes per day (further elaborated below).

- iii. **Eligibility:** The Voting is open to all ages. Any Voters under the age of eighteen (18) or such other age of majority pursuant to the relevant jurisdiction applicable to the Voters must obtain parental and/or guardian approval before participating in the Voting. The Organiser considers it the responsibility of parents and/or legal guardians to monitor the participation of their children (who are below the requisite age of majority) in the Voting.
- iv. All Voters shall be required to adhere to the Award voting mechanism as may be changed, amended, notified, or communicated by the Organiser during the Voting Period.

3. Voting Entries

- i. Each vote by a Voter shall be deemed as one (1) voting entry ("**Voting Entry**").
- ii. Each Voter under the relevant registered Astro ID is restricted to cast up to a maximum of five (5) votes ("**Allocated Votes**") per day during the Voting Period. All Allocated Votes assigned for the day concerned must be utilized by the end of that particular day and can be casted for different Contestants or the same Contestants in a day.
- iii. The Voter must ensure that their Voting Entries are complete and accurate.
- iv. Voters are not entitled to any prize.
- v. Voting Entries received through the Voting Webpage will be subject to verification by the Organiser.
- vi. The Organiser will not entertain any complaints and/or appeals (whether made orally or in writing) with respect to any unauthorised and/or disqualified Voting Entries made by Voters.

4. Proof of Voting

Proof of Voting Entry sent by a Voter does not constitute proof that the Voting Entry was received by the Organiser.

5. Charges

There will be no charges imposed by the Organiser for Voting Entries submitted by the Voters. Any and all costs incurred by the Voters for the Voting including without limitation to, preparation and submission of Voting Entries and participation in the Voting shall be at the Voters' own expense.

The Organiser will not be responsible or liable for:

- i. Any problem, loss or damage of whatsoever nature suffered by any party due to any delay and/or failure in receiving and submitting votes as a result of any network, telecommunication or system error, interruption and/or failure experienced by the Voter's telecommunication service provider and/or by the Organiser and/or resulting from participation in the Voting howsoever arising. In the event of such error, interruption and/or failure, the Organiser shall not be responsible or liable for any failure by any Voter to participate in the Voting at any time.
- ii. Any problem, damage or loss of whatsoever nature suffered by the Voters, or their authorised representatives resulting from their participation in the Voting.
- iii. Any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, destruction, alteration of, or unauthorized, lost, delayed entries howsoever arising (including without limitation as a result of technical faults, server functions, virus, bugs or any other causes).
- iv. Any other errors, acts or omissions whatsoever by the participating service providers of the Voting.

9. Disqualification

Without prejudice to any rights which the Organiser may have in law, the Organiser reserves the sole and absolute right to disqualify any Vote which it determines to be:

- i. Incomplete, invalid, or otherwise not made in accordance with these Award Terms and Conditions herein, or
- ii. Tampering with the entry process or the operation of the Voting, or
- iii. Otherwise in breach or potential breach of these Award Terms and Conditions.

10. Suspension

The Organiser further reserves the right to cancel, terminate, modify, suspend, or delay the Voting in the event of unforeseen circumstances beyond its reasonable control or for any reasons whatsoever at the Organiser's sole and absolute discretion.
